The Council of the Rural Municipality of Morris held its regular meeting on Wednesday, January 9, 2002 at 9:00 a.m. in the Council Chambers of the R. M. of Morris.

School Div Committee Council then held a lengthy discussion on the issues of the Morris Macdonald School Division and the Elected Official Advisory Committee. Most of this discussion concerned the potential Board representatives for the new amalgamated Division.

M. of Morris agree to enter into such a right-of-way agreement and that the Reeve and Municipal Administrator be authorized to sign such necessary documents.

Reeve Herm Martens and Councillor Sieg Neumann returned to the meeting at approximately 11:00 a.m.

Foreman Report Mr. Don Harder, Public Works Foreman, then met with Council.

He indicated that drainage work was shut down on January 4, 2002 but their was still some minor work to be done under the bridge on PR 422. There was some discussion of the spreading of the dirt taken out of the ditch along the Anderson Drain. It was felt that there should be discussion with the Province on the matter that they undertake the spreading or hauling of this excavated dirt

The Municipality should also bill to Dept. of Conservation for the work done by the Municipality on the Shannon Drain.

On the matter of gravel for our roads, Lavallee Trucking is requesting a 3 year deal with a \$.25/tonne increase and is to have an added charge during those 3 years for fuel costs above \$.50/litre for diesel fuel.

On the Rosenort Dyke Diversion, there will be snow problems for those crossings and it is doubtful that we will be able to keep these crossings open. Employees have built and put together a snowblower for the small tractor. He indicated that we should be purchasing additional warranty for the John Deere grader which would cost \$11,675.00 fi the machine is not traded in. Mr. Harder then listed a number of planned repairs to our equipment over the winter months as well as building a cab for the small tractor.

For employees positions, there was a reclassification of some positions and those employees are to be advised of this change and that we would be advertising these positions because of their change.

Don is going on holidays from February 2 to 16, 2002 and Andy Friesen will be in charge while he is on holidays.

Peter Wiebe has now retired as of December, 2001.

There was some discussion on the proposed salary increase.

There is shelves being built and painting being done in the water treatment plants at Rosenort and Lowe Farm.

There are 9 more bridges schedules to be replaced in 2002 at an estimated cost of \$37,000.00 (less discount).

Council then recessed for lunch at 12:00 noon and reconvened at approximately 1:15 p.m.

Staff Sgt. Len Del Pino, of the Red River RCMP Detachment met with Council. He is the new Staff Sgt. at Morris and he discussed by RCMP background prior to his posting in Morris. He also mentioned the operation of the detachment and answered questions of Council.
