Rural Water Lines Moved by Leo Kornelsen, Seconded by Ralph Groening:

#62/02. Whereas the R. M. of Morris has conducted some preliminary work on proposed rural water lines;

And Whereas the Water Services Board requires acknowledgement as to what projects we may wish to proceed with;

Therefore Be It Resolved that the Water Services Board be notified to proceed with the Riverside project and the Rosenort West project as approximately indicated in the Water Services Board letter of March 8, 2002.

Reeve Herm Martens requested a recorded vote on the issue of Conditional Use Application No. 6/2002.

Cond. Use 6/2002 L.Bartel SW 33-5-1W Moved by Sieg Neumann, Seconded by Ralph Groening:

#63/02. Whereas Luke Bartel has made application for a conditional use to allow for the construction and operation of four (4) - 2,500 isowean hog barns livestock feedlot operation in the SW of Section 33-5-1 WPM; And Whereas a public hearing was held for this application on March 13, 2002;

Therefore Be It Resolved that the Rural Municipality of Morris hereby approves this Conditional Use No. 6/2002 subject to the following conditions:

- 1. That all lagoons have a minimum 440 day storage capacity at 3 feet below the lagoon wall elevation level and that barley straw cover, as odour control, be maintained on the lagoons with the barley straw cover installation being done by June 1st each year with the lagoon walls elevated to be at least 2 feet above ground level or 2 feet above the 1997 flood level, whichever is highest.
- 2. That the Morris Livestock Guidelines be adhered to.
- 3. That all additional driveways and access shall be at the expense of the owner.
- 4. That there be a cold storage unit of sufficient size for dead animals or that the operation is to have a container unit with 48 hour dead animal pickup or that the operation compost the dead animals to a method acceptable to Council.
- 5. That a minimum three row tree shelter belt, of a minimum 2 varieties, be planted and maintained around the barn and lagoon site with the trees being planted for the first spring.
- 6. That a 1% refundable performance bond of capital construction costs be submitted to the Municipality and shall be paid when making application for a building permit.
- 7. That the manure disposal be done by direct injection.
- 8. That all material being put into the lagoon shall be only from the direct operation of this hog barn.

- 9. That the owner shall be responsible for the costs involved in the widening or altering of any road corners where their hog operation has caused the need for this road upgrade.
- 10. That a building permit be obtained from the Municipality prior to starting construction of this project.
- 11. That the owner shall be responsible for road culvert and gravel expenses required on the road from the Provincial Road 332 to the barn site for the first year plus 2 more additional years under the R. M. of Morris management with the road in question being South of Section 31, 32-5-1 WPM and a portion East of Section 32-5-1 WPM to the barn site.
- 12. The R. M. of Morris reserves the right to request and demand a plastic cover on the lagoons at any time in the future.
