The Council of the Rural Municipality of Morris held its regular meeting on Wednesday, May 8, 2002 at 9:00 a.m. in the Council Chambers of the R. M. of Morris.

Reeve Herm Martens presided.

Council members present were: Ralph Groening, Sieg Neumann, Stan Siemens, Denis Robert, Barry Fraese, Leo Kornelsen.

Budget Meeting At 9:00 a.m., Council held their public meeting for the 2002 Financial Plan. There was no one present for this meeting and Council discussed aspects of the budget. At approximately 10:00 a.m. the meeting for the Financial Plan was ended.

Page 2 May 8, 2002

Public Works Foreman Mr. Don Harder, Public Works Foreman, then met with Council. He indicated that 5 miles of drainage work has been done and there is approximately 60 miles of drift dirt in ditches caused by recent high winds. The Water & Soil Management Committee felt that the issue of the drift dirt should be dealt with and to undertake cleanout of the drift dirt would cause a substantial change to the planned 2002 drainage work program. We would need to send out s newsletter flyer to all the farmers explaining the situation and possibly have a public meeting to explain the issue of changing the drainage program.

Council also discussed a possible fee for cleaning out the drift dirt from the ditches, however that issue was not discussed further.

Council also discussed the drainage problems of the Tobacco Creek Drain and Drain 111. There was also a general discussion to install culverts through the NE corner of Section 30-5-1 WPM into Drain 111.

Council then recessed for lunch at 12:00 noon and reconvened at approximately 1:15 p.m.

Mr. Harder then continued his presentation to Council. He informed Council that the Prairie Grain Roads Program tenders would be in on Friday, May 10, 2002 and we would know then what the amount would be. There are currently 3 graders on the gravel roads.

For the Lowe Farm water system there was a problem with a pressure valve and there was high pressure in the water lines that did cause some problems to a few houses.

All employees are now working.

The Caterpillar grader has a radiator leak and is now in Winnipeg being fixed

The Sperling water and sewer project is to start this week. Taillieu Construction was the contractor hired for the installation of the main lines for the project. Their portion of the project will take approximately 1 month.

Council discussed the cutting of cattails and what machinery may be available to do such a job. It was felt that a demonstration should be arranged to have a look at the equipment working.

For the drift work needing to be done, a wider bucket on the Track hoe is needed and he wanted to know if purchasing such a bucket would meet council's approval. If the removal of the drift dirt is slow, a wide bucket may be needed for each machine. Council felt that all efforts must be made towards the drift dirt and that a wider bucket should be investigated and acquired if necessary.
