Reports

Committee Reports

Leo Kornelsen – Fire Protection - Lowe Farm F. D. will overspend on their 2002 budget allocations.

- Weed control Dist. area sprayed and withdrawal from the district.
- Riverside Dyke deficiencies have almost been done.
- Barry Fraese Sperling Arena breakfast and meeting and upgrades to the arena

Denis Robert - Morris Arena - initial meeting

Page 2 December 11, 2002

Prov. Drain Brush Clearing Moved by Ralph Groening Seconded by Leo Kornelsen: #228/02. Whereas many Provincial Drains and waterways have become overgrown with vegetation, which inhibits the flow of water along these drains and waterways;

Therefore Be It Resolved that we request the Dept. of Conservation to undertake an immediate program of brush clearing along their drains and waterways;

And Further Be It Resolved that special consideration be given to the Tobacco Drain waterway.

Public Works Foreman Mr. Don Harder, Public Works Foreman, then met with Council. He indicated that all of the dirt spreading work has been done, except for 15 miles.

The joint project between the R. M. of Dufferin & Morris will likely take until December 18, 2002.

Weather permitting, there is plans to dig a new pit for the Rosenort Dump.

He questioned the Rosenort Dyke deficiencies and the operation of the flood gates.

The Municipal truck is hauling bricks from the Eaton's building in Winnipeg and we are able to do about 3 loads per day.

We are currently reading water meters in the Municipality.

For the Sperling Sewer and Water project, the water plant deficiencies have not yet been done. The condition of the yards from the work done for the house connections is not good.

The following is a listing of employee layoffs and final work dates: Doug Bergen, November 29; Jack Toews, November 28; Jack Klassen, December 20; Claude Robert, December 20.

Mr. Harder noted that some employees have additional responsibilities and that their salaries should reflect this.

There is a Provincial Bridge Program and the Riverside bridge needs re-decking and paving and should be considered under this program for which applications must be in by March, 2003.

LUD of Rosenort Mr. Greg Friesen and Mr. Harry Brandt, the LUD of Rosenort Committee, then met with Council to discuss issues and concerns that they have.

The Rosenort Development Corp. has requested a culvert at the south end of Oak Bay. This culvert would be 150 feet long and situated between two lots and covered and they asked that the Municipality and LUD share the cost of this installation.

The Heritage Centre west parking lot is in need of paving and they requested support from the Municipality for this project. It was felt that prices and work requirements be first obtained for the project and then have consideration to the possible cost sharing of the project.

They wanted to know what stage the Morris Development Plan is at and how soon it would be completed. Council was unable to respond to this issue and advised that it may be required for the Municipality to give this project to another company to complete.

Westfield Industries had indicated in the past that they did not wish to retain the property behind the Rosenort Fire Hall and would transfer it to the Municipality. They would contact Westfield Industries and confirm their intention for this property.

Page 3 December 11, 2002

There is some land between Brandt Road and the dyke that is suitable for development and it should be transferred into the LUD of Rosenort. They wanted to know what the process is for such a transfer and that Council consider doing this as soon as possible.

Council then recessed for lunch at 12:15 p.m. and reconvened at approximately 1:15 p.m.

And Whereas this proposed subdivision is for the creation of a 5.16 acre yard site with 4.6 acres being from Lot 4, Plan16518 and .56 acres being from Lot 3, Plan 16518;

Foreman Report At 4:00 p.m., Mr. Don Harder met with Council to discuss issues that have arisen lately. He indicated and the Morris /Dufferin drainage project will soon be stopping. Mr. Ed Penner is having the project stopped and the R. M. of Dufferin equipment will move out immediately and that we will also have to leave the project soon. For the Sperling water and sewer project, there are three connections left and a walk around is scheduled for Friday at 10:00 a.m. to view the Graboweski project work. The water plant still has work to do and the electrician is coming out on Monday to do some of this deficiency work.
