Public Works Foreman Mr. Don Harder, Public Works Foreman, met with Council. He indicated that 32.5 miles of drainage work has been completed and the dirt spreading would be started soon. Any bridge replacements will be done after harvest.

Our gravel program was completed on July 31, 2003. The road to the Jason Holdings barn is holding up very well.

For the Prairie Grain Roads Program, the Municipality was the successful tender bid and the projects will be starting September, 2003. Road 31N between Road 1W and Road 2W has been raised.

For the road into the K Line barns, quotations were given to them on widening the corner at PR 332 and widening the corner to the south barn site. To date there has been no response from K Line on wanting this work to be done.

Manitoba conservation was sent the information on the extra gravel needed for the Rosenort dyke project.

For the Riverside Dyke, Mr. Harder questioned who was responsible for cutting the dyke. Council indicated that we were responsible to cut the dyke and that the cutting would likely be tendered out next year. Crown Utilities has not done the cleanup from the 2002 rural water line project. A letter is to be sent to the Manitoba Water Services Board indicating the need to have this cleanup done immediately or that the Municipality would hire someone to do this cleanup work.

The seal coating has been completed on the road north of the Riverside park.

Two grader operators will be taking holidays in August.

Mr. Harder asked about hiring an operator to run the rotary ditcher unit and that the Municipality could rent a tractor for the rotary ditcher. Also discussed were the possibilities of renting out the rotary ditcher with tractor and operator.

Advertise Operator for Ditcher Moved by Denis Robert, Seconded by Lionel Wiens; #181/03. Resolved that we advertise for the hiring of an operator for the rotary ditcher and tractor unit.
