The group is hoping to obtain \$1,500.00 from each of the Town of Morris, the R.M. of Morris, the Province of Manitoba and the Federal Government each. This money would entitle each level of government to have their logo on the front of the magazine and to have a message on the inside. This magazine would also include a community events calendar.

Cindy Todd and Connie Gonty attended the meeting at 10:00 a.m. Miss Gonty reviewed a survey that she had completed in schools in the R.M. as well as a listing of programs that would be available in the summer.

The CAO was instructed to check into curling signs and surplus equipment that was sold from the Lowe Farm Utility Fund.

Mr. Don Harder, the Public Works Foreman attended the meeting at 11:30 a.m. He reported that they have completed 7 miles of drainage. They are planning to do some testing on the directional drilling tomorrow. Mr. Harder questioned Council on how much Dust Control was to be applied at Riverside. The Public Works crew is busy preparing the communities for dust control. Lavallee is now ready to do some spot gravelling. Mr. Duane Boutang is coming on Friday to open the road tenders. Under the Rural Water, Mr. John Enns is now making some good progress. There have been two water breaks one of which was under warranty. The dandelions have all been sprayed and Alvin Wiebe has taken a GPS Course. The R.M. of Morris will be obtaining the appropriate equipment from the R.M. of Rhineland.


