Council discussed the refund of the performance bond amounts. After the barn is set up and operating properly one half of the performance bond is to be refunded. The other half will be refunded after three consecutive good years of operation.

Council discussed the Prairie Grain Roads Program and decided that the first choice would be the road running from Rosenort to Sanford, the second choice would be several roads in the Sewell and Pleasant Valley areas. This matter will be brought forward to the August agenda.

Resolved that Shoreline Swine be refunded ½ of their performance bond.

The CAO was instructed to tender for audit services for a 4-year period. These tenders were to be by invitation and were to be sent to 6 separate firms.

The CAO was instructed to meet with the public works foreman regarding the CN rail crossing removal.

Council of the R.M. of Morris set a policy that they will pay the fees for approved courses on the condition that the Employee's reimburse if they fail the course or they leave employment before the course is done.

The CAO was instructed to obtain the total costs of the directional-boring machine.

Councillor Groening reported on the petition Mr. John Kostal had presented for the supply of water North of Aubigny.

The CAO was instructed to draft a letter advising the R.M. will try to tender for the main line this year but will make a firm commitment for next year. This letter will also request a \$500.00 deposit from all interested persons to be received by August 10th, 2004.

Council Groening reported that he had questions regarding a drainage culvert North of Kane. Councillor decided that the RM of Roland could lower this culvert at their cost.

There was some discussion concerning the 4-N drain and the Tobacco Creek. These need to be cleaned out. There has been no maintenance for at least 37 years. Councillors decided that step number one would be to go to meet the Minister. The CAO was instructed to write a letter and invite Mr. Steve Topping with Mr. Steve Ashton. If this meeting is not successful council will consider a 50/50 cost sharing.

There was some discussion concerning the Scott Parker dyke. The CAO was instructed to send a letter to the Province to the Minister in charge of MEMO and ask for dyke repair. The R.M. of Ritchot and the R.M. of McDonald will also be asked for support. On another project on the Montcalm Morris border the DFA did the necessary repairs.

Council reviewed the priorities that had been set in December. The list of current priorities is attached to and forms part these minutes.
