He has done some spot gravelling on the roads. Mr. Harder also mentioned three separate roads to pig barns and the cost associated with each. Under the Rural Water Program a total of 102 connections have been made. There will be a total of 109. Mr. Harder expects that the crew will finish on Tuesday and clean up the machine on Wednesday. Lavallee has started hauling gravel for the paving in Lowe Farm. This gravel will be stockpiled over the winter to be used next year. Andy Friesen will start ditching in Lowe Farm as soon as the water connections are finished. The electricians are almost finished hooking up the panels in the water plants. The weed control chemical cost were \$28,206.00 for this year. Time spent was approximately \$3,750.00 with a fuel bill of \$900.00. Mr. Harder also advised that the fourth grater would be going next week. The Scott Parker dike is not R.M. of Morris property and the dike should not affect drainage.
