Minutes of a meeting of the Council of the Rural Municipality of Morris held on Wednesday, August 10th, 2005 commencing at 9:00 a.m. Reeve Martens and Councillors Groening, Fraese, Kornelsen, Neumann and Robert were present with Reeve Martens in the chair. Councillor Wiens had sent his apologies.

The C.A.O. was asked to phone the Honourable Steve Ashton regarding the requested meeting. The C.A.O. was also asked to write to the Premier again asking for an accounting of the dyke costs. The C.A.O. was further instructed to write again regarding the railway crossing on the Horndean road. The C.A.O. was further to write to CN regarding the first two crossings west of Town.

Mr. Arthur Dueck attended the meeting at 10:15 a.m. He advised that he had a total of three issues. The first issue is the Riverside dyke and his ongoing battle to collect monies from the Province that he feels are owed to him. The second issue is the Riverside bridge. Mr. Dueck feels that the corner markers should be moved back about 50 feet so that farm machinery could be taken across this bridge. Mr. Dueck third issue was a flood access road. He requested that Council build up approximately 1 mile of road so that he would have access to his place during a flood.

Mr. Lawrence Dyck attended the meeting at 10:30 a.m. He advised Council that he farms in the R.M. of Morris and lives in Roland. Mr. Dyck rents a section of land from a German owner. His contract stipulates that he must keep the taxes up-to-date. There are some arrears on this property as a result of a utility bill being added to the property. Mr. Dyck argued that this utility bill has nothing to do with the land, the owner, or himself. The arrears are still there and Mr. Dyck does not accept someone else's bill on his land taxes. Mr. Dyck does not agree that water being hauled is a service to the property.

Mr. Don Harder attended the meeting at 11:00 a.m. He advised that 8 miles of drainage has been done and he expects that most of the planned drainage work will be done this

year. Mr. Harder wants to start spreading dirt the third week in August. Approximately ¼ of the road gravelling has been done, and the R.M. should anticipate a fuel surcharge of up to \$7,000.00. Mr. Harder advised that Borland Construction is planning to start paving in Lowe Farm on Friday and to be done by Tuesday. The R.M. of Morris would then do the shoulder work and clean up. Mr. Harder reported that under rural water, $5\frac{1}{2}$ miles of 4-inch piping has been trenched and they are now doing the 3-inch going North. A total of 36 services have been done. Mr. Harder reported that he expects to start work on the Industrial Park streets and sewer and water in October. Lewis Instruments has given him an updated price of \$24,900.00 for the new GPS tower. His price can be reduced by \$10,000.00 or \$12,000.00 dollars because the R.M. has a base unit. Weed Control is presently working on cattail: Mosquito fogging is being done during late evenings. The R.M. will be receiving some revenue for tractors pumping at the dykes. 1 is hoped that this money will be able to go into the Warranty Reserve. Mr. Harder also reported that weed spraying for the Department of Highways will total \$14,000.00. Mr. Harder is waiting to hear back from Duane Boutang on the Prairie Grain Roads Program Mr. Harder is unable to go on the tour with Toromont Cat to their plant in Illinois and Councillor Kornelsen was appointed to attend in his place.

Reeve Martens advised that he would like to meet with Duane Boutang when they come out to open the tenders.

Mr. Ray Muller attended the meeting at ± 20 p.m. Mr. Muller mentioned that there was some question about a fine that had been levied on a certain hog barn. This fine had bee charged in either 2002 or 2003. Mr. Muller discussed performance bonds and unsightly buildings with Council.

It was decided that Mr. Muller will meet with the Livestock Committee on August 19th, 2005 at 8:30 a.m. They will then make recommendations on all the performance bonds to Council. The C.A.O. was asked to check the minutes from 2002 and 2003 to see if there was any record of a fine having been paid.

Reeve Martens reported on the meeting that had been held with the Honourable Ron Lemieux and advised that we had received a good hearing. Mr. Martens also reported o the Devils Lake meeting that was held on August 9th, 2005.

Councillor Groening reported that there is still high interest in rural water. Councillor Groening also asked that the Valley Ag Society be removed from his committee listing.

Councillor Fraese reported that Sperling had raised \$25,000.00 for their cemetery project

Councillor Kornelsen reported that the Rosenort C.C.D. had been approved for a government grant. The grant had not yet been received, which is why they had asked fc and advance on the R.M. levy.

Marge Heinrichs attended the meeting at 2:30 p.m. and presented Council with a draft tourism brochure. This brochure gave brief descriptions of each community together with numerous pictures.

The C.A.O. was asked to obtain opinions from surrounding municipalities regarding the reporting program for social assistance
