WHEREAS Provincial Road 205 running west of Rosenort beginning at the Morris River diversion up to the Provincial Road 422 intersection, is already hard surfaced, however is in need of repairs and also in need of an increase in elevation to avoid water overflow; NOW THEREFORE BE IT RESOLVED THAT we request Manitoba Infrastructure & Transportation to:

- 1. Reconstruct PR 205 from the Morris River Diversion bridge running west to the PR 422 Intersection, to provide for an increase in elevation to 2009 flood level plus 1 foot, or the height of the proposed new bridge crossing the Little Morris River on PR 422, whichever is the higher level.
- Increase the weight classification to provide for the same weight classification as PTH 23, west of the Town of Morris, and PR 205 (from PTH 75 to Rosenort).
- 3. Increase and reconstruct PR 422 from the PR 205 intersection running south past the bridge over the Little Morris River to the point where the road elevation is increased.
