2. Conditional Use No. 02/2017 – H. Fehr Co. Ltd. & Cleason Bauman:

THEREFORE BE IT RESOLVED THAT Conditional Use Application No. 02/2017 be approved as applied for subject to the following conditions:

1. Manure Management

- THAT if a manure pile is established that it shall be located towards the rear of the property.
- THAT the applicant shall supply a formal agreement, with the adjacent landowner, to have the right to spread the manure on subject land.
- THAT any manure shall be spread at a minimum of once per year. The spread manure shall be incorporated into the soil as according to provincial regulations.

- THAT the housing of animals shall be in the existing Quonset plus a corral system. Should other buildings on the yard be used for housing of the sheep, the total number of sheep shall not exceed 500 in total.
- 3. Additional Consideration
 - THAT the Conditional Use be restricted to a maximum of 500 sheep/ewes.
