### **Drainage:**

- 2 ½ mile have been done;
- There will be a lot of dirt spreading to do this fall after harvest to try and get caught up.

#### Roads:

- Road gravel is being hauled by Lavalee from the pit and should be completed by approximately May 12<sup>th</sup>;
- Road gravelling from the stockpile will start approximately May 15<sup>th</sup>.

#### Various:

- Culverts in the communities are repaired;
- Straw at various locations has been hauled and cleaned up;
- Planting trees in Rosenort;
- Street sweeping in communities has been done;
- Start dust control sites in rural areas mid-May;
- Start on culvert repairs in the rural area.

#### Additional Items:

- Hoping to get caught up on drainage. The dirt piles are too wet to spread;
- Burning at the landfill is on hold due to the wind;
- Brandt Road in Rosenort water line will be starting as soon as possible. A
   6" line will be installed in front of the properties due to the desire for fire hydrants;
- Trees have been planted on Kroeker Street and at the existing east dyke in Rosenort;
- Dust control is slated to start on May 18<sup>th</sup>;
- Some street repair in Sperling will need to be scheduled for next year.
   Larger trucks are creating some damage.

#### 8.5 AMM Education Resolution:

WHEREAS the education funding model in Manitoba has been in existence for many years and is in need of a major review;

AND WHEREAS education has traditionally been jointly funded by a portion from the Provincial Government and a portion by the local Municipal Governments; AND WHEREAS several organizations such as the Association of Manitoba Municipalities (AMM), the Manitoba Municipal Administrators Association (MMAA), the Manitoba School Boards Association (MASB) and Manitoba Association of School Business Officials (MASBO) are all involved in the process of creating the financial plans for school divisions, levying for and collecting the taxes:

AND WHEREAS it would be deemed prudent to request the Province of Manitoba to establish a task force to review how education is funded in Manitoba; NOW THEREFORE BE IT RESOLVED THAT we request the AMM to lobby the Provincial Government to establish a task force to review how education is funded in the Province of Manitoba;

AND FURTHER BE IT RESOLVED THAT such a task force include representatives from AMM, MMAA, MASB, MASBO and such other individuals as the Provincial Government deems appropriate.

### 8.6 AMM Municipal Act Amendment:

WHEREAS the Municipal Act 186 (1) reads in part "An auditor must examine..." and 186(1)(c)(i) reads in part "to which the municipality has made a grant or loan of money of \$5,000.00 or more..",

AND WHEREAS the \$5,000.00 level requiring audit is outdated given current levels of regular Municipal Funding provided;

THEREFORE BE IT RESOLVED THAT the AMM, in partnership with the MMAA, lobby the Province of Manitoba to amend the Municipal Act to either remove Clause 186(1)(c)(i) from the Act, or increase the amount to a more reasonable limit.
