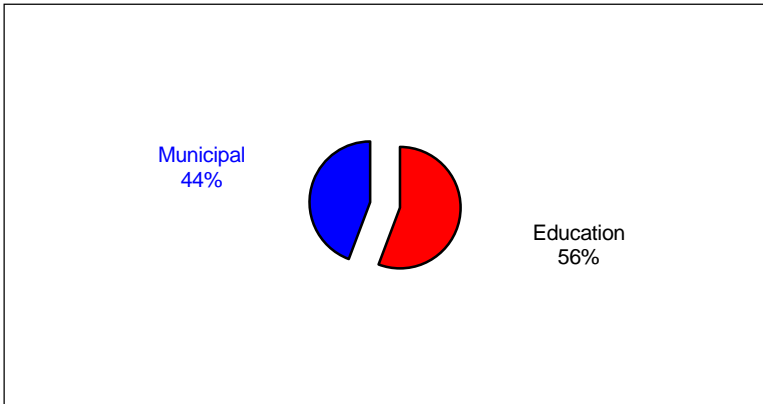

## ASSESSMENT

Every couple of years the Provincial Assessment Department conducts a Province wide reassessment. This will take place in 2020. The assessment on this years tax invoice is reflective of the market value as of April 1, 2016.

## MUNICIPAL PORTION

The Rural Municipality of Morris has recently approved its municipal budget. In 2018 the Municipality budgeted to collect municipal taxes in the amount of \$4,118,551.20 and in 2019 this amount is budgeted to be \$4,152,766.10.

In 2019 the Rural Municipality of Morris has budgeted expenditures totaling \$6,224,097.85, excluding education payments. The graph on the next page shows where the budget has been allocated.

Please bring your tax notices when making payment, or send stubs if mailing.

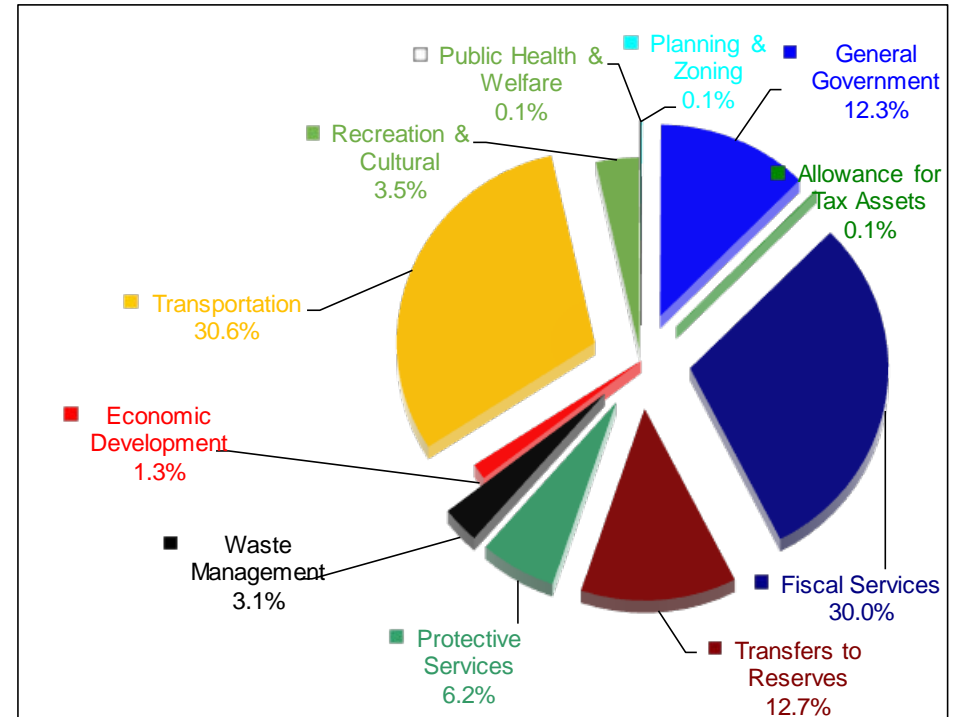
