

The Rural Municipality of Morris

BY-LAW NO. 1639/08

BEING a by-law of the Rural Municipality of Morris to establish a rate for recreation services within the municipality as a special service from 2009-2013, inclusive.

WHEREAS Section 312 of *The Municipal Act*, S.M. 1996, C.58, provides in part, as follows:

(312) If approved by by-law, a municipality may provide, as a special service to all or part of a municipality, one or more of the following:

...
(g) recreation support services
...

AND WHEREAS subsection 320(1) of *The Municipal Act* provides as follows:

"Subject to subsection (2) to (6) and subsection 321 (4), a council may by by-law

- (a) approve the local improvement or special service as set out in the plan or proposal; and
- (b) authorize the municipality to impose taxes as set out in the plan or proposal.

AND WHEREAS the Council of the Rural Municipality of Morris has prepared Special Service Plan No. 1/2008 to establish six special service areas and six rates for recreation services in the RM of Morris pursuant to Part 10 of *The Municipal Act*, which plan is attached hereto as Schedule "A";

AND WHEREAS the requirements as prescribed in Sections 318, 319 and 320 of *The Municipal Act* have been complied with;

NOW THEREFORE the Council of the Rural Municipality of Morris, in regular meeting duly assembled, enacts as follows:

1. That pursuant to subsection 320(1) of The Municipal Act, the Rural Municipality of Morris adopt Special Services Plan No. 1/2008 attached hereto as Schedule "A".
2. That the Rural Municipality of Morris establish six Special Service Areas as follows;

Sperling – Urban, Sperling – Rural, Rosenort, Aubigny, Lowe Farm/Kane and Morris.

3. That each Special Service Area shall consist of the properties set out in the attached schedules;

Sperling, Urban	Schedule "B"
Sperling, Rural	Schedule "C"
Rosenort	Schedule "D"
Aubigny	Schedule "E"
Lowe Farm/Kane	Schedule "F"
Morris	Schedule "G"


4. That in each year, the Rural Municipality of Morris shall levy an annual special service tax on all ratable property in each respective Special Services Area sufficient to raise following amounts;

R.M. of Morris CCD's	Total Annual Levy
Sperling, Urban	\$3,947.40
Sperling, Rural	\$8,952.60
Rosenort	\$65,000.00
Aubigny	\$12,000.00
Lowe Farm/Kane	\$25,000.00
Morris	\$15,396.00 up to \$16,396.00
