WHEREAS the Rural Municipality of Morris has received quotations from three suppliers for the supply of four grader units and one excavator;

AND WHEREAS after review of the quotations it has been determined that it is in the best interests of the Rural Municipality of Morris to purchase an excavator and lease the grader units for two years;

NOW THEREFORE BE IT RESOLVED THAT we enter into a lease agreement with John Deere and Brandt Tractor Ltd. for the lease of four new John Deere 872G Graders for a period of 24 months at a monthly lease cost of \$3,714.00 per unit per month;

AND FURTHER BE IT RESOLVED THAT we purchase a new John Deere Model 210GLC Hydraulic Excavator from Brandt Tractor Ltd. for a purchase price of \$218,000.00 plus applicable taxes;

AND FURTHER BE IT RESOLVED THAT the Reeve and Chief Administrative Officer be authorized to sign any documents related to these transactions on behalf of the Rural Municipality of Morris.
