

BY-LAW NO. 1095.

Being a by-law of the Rural Municipality  
of Morris to establish the Rosenort  
Community Centre District.

WHEREAS pursuant to Section 432 (1) of The Municipal Act, C100, S.M.  
1970, a council of a municipality may, among other things, establish community  
centres;

AND WHEREAS it is the intention of the council of the Rural  
Municipality of Morris to establish several community centre districts within  
its boundaries;

AND WHEREAS it is deemed expedient at this time to designate the  
area and boundaries of the various community centre districts so as to  
ultimately proceed to the erecting, maintaining and regulating of various  
community centres;

NOW, THEREFORE, be it enacted and it is hereby enacted as a  
by-law of the Rural Municipality of Morris, duly assembled as follows:

1. THAT the Rural Municipality of Morris hereby establishes "The  
Rosenort Community Centre District" which shall be comprised of those lands  
described in Schedule "A" to this by-law.
2. THAT the Reeve and Secretary-Treasurer be and are hereby authorized  
to do all things necessary to give force and effect to this by-law.

Township Five and Range One, East of the Principal Meridian, in

- Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17,  
18, 19, 20, 21, 22, 23, 24, 28, 29, 30, 31, and 32, all in  
Township ~~Five~~ and Range One, East of the Principal Meridian, in  
Manitoba.
  
- The West Half of Section Thirty, all of Section Thirty-one, in  
Township Five and Range Two, East of the Principal Meridian, in  
Manitoba.

#4/79. Whereas By Law #1095 has set out boundaries for the  
Rosenort Community District:


Now Therefore Be It Resolved that we amend the By-Law to  
change the boundaries to include, on Schedule A of this  
By Law:


Sections 25, 26, 27, 33, 34, 35, 36, all in Township 6,  
and Range One East of Principal Meridian, in Manitoba.  
Sections 30, and 31, all in Township Six, and Range Two  
East of Principal Meridian;

And Further, that we delete parcels of land from Schedule A:  
The South Half of Section 9, and all of Section 10, South-  
East Quarter of Section 24, All in Township Five, Range  
One East of the Principal Meridian, in Manitoba, as well  
as Section Eighteen, Township Six, Range Two East, and  
the South West Quarter of Section 30, in Township Five,  
Range Two East of Principal Meridian, in Manitoba;  
And Further, that By Law #1095, as so amended, be read  
a second time."
