

## Education Levy Information

As a municipality we are tasked with the responsibility of collecting funds for the Education Authorities. We collect education funds on behalf of the Province of Manitoba for the Provincial Education Support Levy and also three local School Divisions, namely Red River Valley School Division, Prairie Rose School Division and Borderland School Division. The total amount of Education Taxes for 2019 that we as a municipality have to collect on their behalf is shown below:

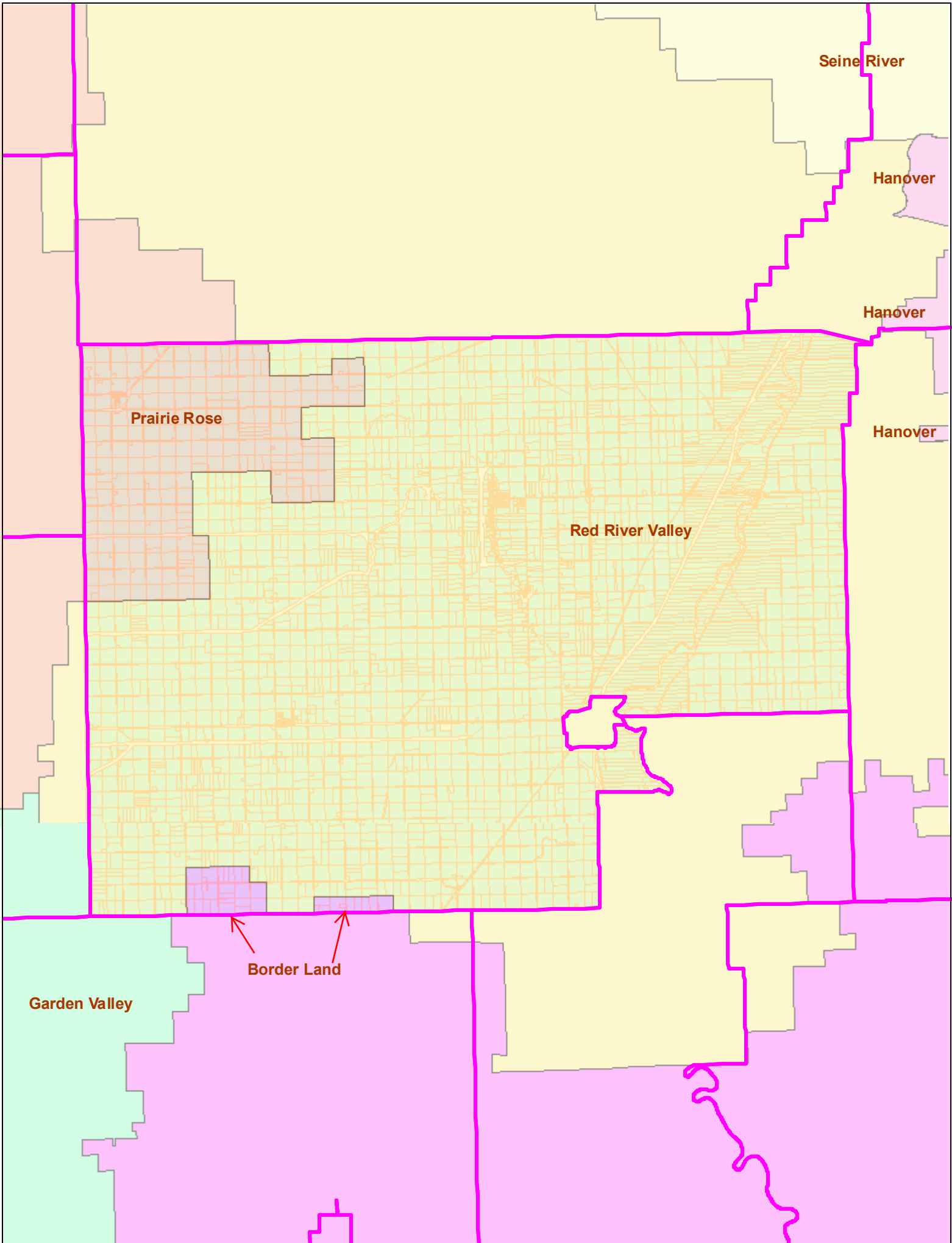
